On 4-15-89, at approximately 12:25 a.m., my partner Sgt. E. Martig and I responded to a call at 1014 7th St. reference a stabbing to back up Off. E. Kearney and his partner Sgt. Wyrd. Before arriving at the scene a PIO was put out on the description of the suspect. The PIO described the suspect as being a 34 year Hispanic male with a moustache, wearing a brown t-shirt and blue jean jacket. About that time we saw a suspect matching that description walking at Buford and 3rd St. Upon making contact with the suspect we found him to be the same suspect wanted for the stabbing at 1014 7th St. The suspect was then arrested and taken to City Jail. The knife that was found on the suspect was then tagged at the City Jail for evidence (#23195). The blood stained blue jean pants that the suspect was wearing were photographed by I.D. Technician M. Harris #067 and were then tagged as evidence (#23197).

The knife was found in the back right blue jean pants pocket by my partner Sgt. E. Martig.

Before arriving at the scene a PNO was put out on the description of the suspect. The PNO described the suspect as being a 34 year Hispanic male with a moustache, wearing a brown t-shirt and blue jean jacket. About that time we saw a suspect matching that description walking at Buford and 3rd St. Upon making contact with the suspect we found him to be the same suspect wanted for the stabbing at 1914 7th St. The suspect was then arrested and taken to City Jail. The knife that was found on the suspect was then tagged at the City Jail for evidence (#23195). The blood stained blue jean pants that the suspect was wearing were photographed by I.D. Technician W. Harris #067 and were then tagged as evidence (#23197).

The knife was found in the back right blue jean pants pocket by my partner Sgt. E. Hattie.

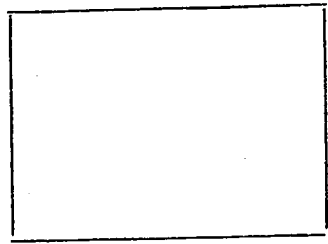

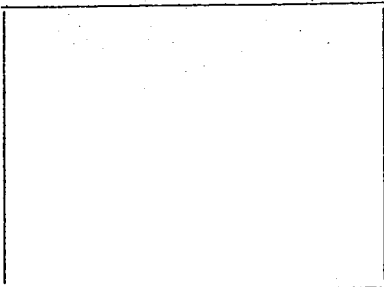
