Offenses Charged at Arrest



The purpose of this report is to record the final disposition of an arrest previously reported to the DPS by your agency. Interim disposition information, e.g., Released on bond, should not be submitted. The subject's name, contributor and arrest number should be exactly the same as they appear on the fingerprint card reporting the initial arrest to the DPS. The DPS number should be indicated, if known. Complete and mail this form to: Crime Records Division, Texas Department of Public Safety, Box 4143, Austin, Texas 78765.

When arrested person is convicted or enters a guilty plea to a lesser or different offense than that charged when originally arrested, this information should be clearly indicated.

It is vitally important for completion of subject's record in DPS Identification files that a Final Disposition Report be submitted in every instance where fingerprints were previously forwarded without final disposition.
