SYNOPSIS:

ON 03-15-94 AT APPROXIMATELY 6:18 P.M., CORPUS CHRISTI POLICE DEPARTMENT NARCOTICS SQUAD EXECUTED A SEARCH AND ARREST WARRANT AT 411 N. SHORELINE, ROOM #107. SUSPECT, MARY ELLIS (A.K.A. TOMBOY) WAS FOUND IN POSSESSION OF A LARGE SUM OF MONEY AND A QUANTITY OF HEROIN IN HER PANTS POCKETS. ALSO, AN ADDITIONAL QUANTITY OF HEROIN WAS SEIZED FROM ATOP THE ROOM'S NIGHTSTAND. DURING THE SEARCH OF THE ROOM, SUSPECT, CARLOS HERNANDEZ, ARRIVED IN SUSPECTED VEHICLE #2 AND WAS FOUND TO BE IN POSSESSION OF A QUANTITY OF HEROIN. OFFICERS INVOLVED IN THE SEARCH: LT. J. MOSELEY #382, SGT. J. CERVANTES #781 (CASE AGENT), SGT. C. BARTELS #442, SGT. J. MILLS #570, SGT. R. LUZANIA #592, AND NARCOTICS DRUG DOG, "ROBBIE".

DETAILS:

1. ON 03-15-94 AT APPROXIMATELY 6:18 P.M., CORPUS CHRISTI NARCOTICS OFFICERS ENTERED ROOM 107 LOCATED THE HARBOR INN BAYFRONT (411 N. SHORELINE). SUSPECT MARY ELLIS WAS APPREHENDED AND SECURED AS SHE WAS LAYING ON THE BED. SGT. J. CERVANTES #781 (CASE AGENT) THEN ADVISED SUSPECT, MARY ELLIS, THAT CORPUS CHRISTI NARCOTICS OFFICERS WERE EXECUTING A SEARCH AND ARREST WARRANT. SGT. J. CERVANTES #781 ALSO HANDED SUSPECT, MARY ELLIS, A COPY OF THE SEARCH AND ARREST WARRANT.

2. AT APPROXIMATELY 6:20 P.M., SGT. J. CERVANTES #781 READ SUSPECT, MARY ELLIS HER MIRANDA RIGHTS. MARY ELLIS ACKNOWLEDGED HER RIGHTS AND SIGNED A MIRANDA WARNING FORM. SGT. J. CERVANTES #781 THEN ASKED SUSPECT, MARY ELLIS IF THERE IS ANY DRUGS OR LARGE SUMS OF MONEY IN THE ROOM. SUSPECT, MARY ELLIS STATED THAT SHE HAD SOME DRUGS AND MONEY IN HER PANTS POCKETS. SGT. J. CERVANTES #781 REQUESTED FROM POLICE DISPATCH A FEMALE OFFICER TO SEARCH SUSPECT, MARY ELLIS. SUSPECT, MARY ELLIS, WAS LEFT IN THE ROOM AND THE OFFICERS STARTED TO SEARCH THE ROOM.

3. AT APPROXIMATELY 6:32 P.M., SGT. R. LUZANIA #592 LOCATED A WHITE PLASTIC PILL BOTTLE CONTAINING A CLEAR PLASTIC BAG WITH A CLEAR PLASTIC BAG CONTAINING THREE CLEAR PLASTIC BAGS, EACH WITH A LIGHT BROWN POWDER SUBSTANCE. THE PILL BOTTLE WAS LOCATED ON THE NIGHT STAND NEAR THE RIGHT SIDE OF THE BED. THE EVIDENCE WAS PHOTOGRAPHED AND THEN SEIZED BY SGT. J. CERVANTES #781.

4. AT APPROXIMATELY 6:37 P.M., SGT. R. LUZANIA #592 LOCATED FIVE BLUE TABLETS WRAPPED IN A LITTLE CAESARS PIZZA COUPON. THE TABLETS WERE EACH INSCRIBED WITH "ROCHE 10". THE TABLETS WERE LOCATED IN A PLASTIC BAG FOUND ON THE ROOM DRESSER. THE EVIDENCE WAS PHOTOGRAPHED AND THEN SEIZED BY SGT. J. CERVANTES #781.

5. AT APPROXIMATELY 6:40 P.M., A VEHICLE PULLED UP AND PARKED DIRECTLY IN FRONT OF THE ROOM'S DOOR. SGT. J. CERVANTES #781 PEEKED OUT THE FRONT WINDOW AND OBSERVED ONLY A HISPANIC MALE (LATER IDENTIFIED AS SUSPECT, CARLOS HERNANDEZ) SITTING ON THE DRIVERS SEAT. SUSPECT, CARLOS HERNANDEZ, THEN MOTIONED SGT. J. CERVANTES #781, WHO WAS LOOKING THROUGH ABOUT A ONE INCH CRACK OF THE CURTAIN TO COME OVER. AT THIS POINT, SGT. J. MILLS #570 AND SGT. R. LUZANIA #592 EXITED THE ROOM AND SECURED SUSPECT, CARLOS HERNANDEZ AND HIS VEHICLE. SUSPECT, CARLOS HERNANDEZ, WAS THEN ESCORTED INTO THE ROOM. SGT. J. CERVANTES #781 ASKED SUSPECT CARLOS HERNANDEZ WHO HE WAS LOOKING FOR AND HE STATED THAT HE WAS WAITING FOR A FRIEND WHO WAS STAYING IN A ROOM UPSTAIRS. SGT. J. CERVANTES #781 THEN RECALLED THAT THE SUSPECTED VEHICLE (1980 CHRY. CORDOBA, TEXAS LICENSE PLATE 515-UYX), BEING USED BY SUSPECT, MARY ELLIS, CONTAINED A VEHICLE TITLE INDICATING THAT IT WAS REGISTERED TO A CARLOS HERNANDEZ. SGT. J. CERVANTES #781 THEN ASKED SGT. R. LUZANIA #592 TO CONDUCT A

PAT DOWN OF SUSPECT, CARLOS HERNANDEZ. DURING THE PAT DOWN, SGT. R. LUZANIA #592 FELT A PLASTIC PACKAGE CONTAINING A HARD ROUND OBJECT IN SUSPECT, CARLOS HERNANDEZ FRONT LEFT PANTS POCKET. SGT. R. LUZANIA BELIEVED THIS PACKAGE TO BE THE SAME TYPE OF PACKAGE THAT IS USED TO STORE ILLEGAL DRUGS. SGT. R. LUZANIA #592 REMOVED THE PACKAGE AND OBSERVED IT TO BE AN EMPTY MARLBORO CIGARETTE PACKAGE CONTAINING A ROUND BROWN PLASTIC TAPE WRAPPED PACKAGE. SGT. J.
