On 11-20-79 at approximately I received a call to go to the 1500 block of Caldwell in reference a D.O. A. Upon arrival I was directed to a vacant lot at Mexico and Mussett. Officer Garcia had arrived at the scene before I did. He showed me a van that was parked in some high weeds in the southeast section of the lot. There was a dead nude female laying on her side in the back of the van. There had been a small child in the van before I arrived. The child was not harmed, and officer Judy Patton took the child to the police station before I arrived. The license on the van was [REDACTED]. It is registered to Apolinan Dalia Saucedo of 1806 Cliff Maus. It is a brown and silver 1979 Dodge van, it is called a House van. An ID Unit was requested and officer Sara Cooks arrived to take pictures and process the scene. Lt. F. Graham was also at the scene. The medical examiner was notified and officer Escobedo and Lt. Pace arrived at the scene.

At this point Captain Wimbish arrived at the scene and told us that a male subject without a shirt or shoes, who had blood on him was at 1509 Caldwell. I went with Lt. Pace to that location to check on the subject. We contacted Mr. Bennie Camero at 1509 Caldwell, and he told us that the subject in question was an anglo male named Jerry Condo who lives at 1509 Caldwell apartment #2. He stated that Jerry Condo had a cut hand, and had scratches on his face and his back. We checked and found bloodstains on the front screen door of apartment #2. We knocked on the door but got no response. After I left the scene of the D.O.A. Dr. Rupp authorized removal of the body to M.M.C. Crest Ambulance removed the body and Ayers Wrecker took the van to the city pound. I was advised that the subject named Jerry Condo was picked up at M.M.C. for questioning. He gave Sgt. Sidney Smith permission to search his residence at 1509 Caldwell apt. #2. I did not go with Sgt. Smith so I don't know any more about the search. No other information.

At approximately 2:30 p.m. 11-20-79 I heard a call go out for unit 12, Sgt.Boos to 1509 Caldwell reference a possible dead body. I started to go to 1509 Caldwell and got there before unit 121. There I was met by Joe Duran 18 YOA DOB 1-17-61 from 1509 Caldwell phone 884-3849 he told me to go with him to a location where a van had a dead body (woman) in it. He took me to Mussett and Mexico and showed me the van off the road in field. I went up to the van a 1979 Dodge Van brown in color bearing Texas 80 [REDACTED] with the side doors open and a latin female without clothes dead inside. Also in the van was another latin female approximately 2 1/2 YOA name unknown. I covered the body and removed the child from van. At this time unit 121 Sgt.Boos arrived and took over, I talked to the 2nd person who was with Mr. Duran when the body and van were found. He was Emilio Parker 15 YOA DOB 3-30-69 phone 888-5864 from 1509 Caldwell also at the scene was unit 115 Officer Patton who took the 3 YOA female to the station and away from the scene. Both witnesses told me they were walking through the field to go get the bus so that subject Parker could get to school. They saw the van. Both thought the van was stolen. They went up to it and saw the dead woman and child in the van. They called police. I transported both to the station for statements.

While working in the CID office I received a call from a Mr. Rudy Cantu of 6609 Canyon Creek, 854-2967. Mr. Cantu is a city employee CETA Administrator, 884-3011, Extension 287 or 387. Mr. Cantu related that yesterday, 11-19-79 at 12:15 p.m. while he was stopped at a stop sign, he saw a van, which he recognized as being the same van pictured in the paper, today, pull into the Exxon Service Station, at Hi Ways 665 and 77. He said he noticed then that the van was damaged to the back and side, (passenger side door) and that it apparently had a flat to right front. Also that it looked like it had been driven flat. He saw a female sitting on the passenger side window, and that a mexican male was driving wearing a hat. He could offer no other description on driver. Mr. Cantu was sure though that it is the same van. He was not sure if there were any other occupants, but thought he could detect some movement in the back.

On this date at approximately 7:20 p.m. reporting officer was dispatched by Lt. Pace to go to 1509 Caldwell to investigate a DOA. I proceeded to that location and upon arrival was advised by the dispatcher that the correct location for the dead body would be Mexico and Musset. I went there. Upon arrival I was directed to a 1979 Dodge Van, of varying shades of brown, Texas license [REDACTED]. I observed that the van had some silver tape around the window's edge on the rear panel doors and along the outer edges of the door and between the closings. The picture window on the right hand side, nearest the rear also had silver tape covering all around the edge of the window. The right rear panel door was observed to have sustained some damage from some type of collision. The double panel doors on the right were opened. I observed a young latin female, having black curly medium length hair. At the time she was covered with a yellow sheet which had been draped to cover her. I removed the sheet. I further observed a contusion to the left eye; there was some blood about her nose area; I also observed some bleeding around the mouth and what appeared to be some contusions. I saw she had a gold tooth on the left upper tooth of her mouth. The woman's body laid on her right side and the lower part of her body laid up against a round wheel which is normally used to secure the spare tire. On the woman's upper left buttock area there was a bite mark which was almost a perfect circle formation. After Dr. Rupp arrived he moved the body and a large cut slashed on her back was observed. Also there was a possible stab wound, it appears to be what is usually called a "hesistation" cut, the skin is broken. There is also a slash mark on her right buttock. A copper penny is sticking to her back; also a possible pubic hair is sticking to her upper left buttock area. I observed that there was possible seminal fluid running down between her legs; and there also appears to be more fluid between her buttocks. Her left arm rested across her abdomen area; it had some blood smeared on the upper arm. Her right arm is tucked under her right side.

Outside of the van, on the grass lays a brown, with variegated colors, sandal. Its pair is observed in the van. The woman's feet laid near the spare tire which in turn was resting against the rear bench seat. A pair of little girl's white socks were laying close to her feet. I observed that the woman's left little toe was lacerated. On the brown bench seat, rear, near the left side of the van there was a pink plastic baby bottle laying on its side. The bottle was empty. Between the rear seat and the bar there laid on the floor an old rusty looking kitchen knife. On the bar there was an open Root Beer Can; In the bar sink I observed it to be full with empty dirty cups and plates. There is a woman's beige bra, strapless laying on the floor near the bar; also laying between the victim's legs and the bar is a four way lug wrench. Directly in front of the bar is a pair of women's high-heel sandals, black in color. On the right of the bar on the floor, laying between the bar and a captain's chair is a pair of men's cotten underwear, with a red, white, and blue design on the. On the Captain's chair, located behind the driver's seat is a pair of women's panties, white in color with a multi-colored print on them. There is also seen a Tampex, partially extending from the cylindrical cardboard container; it is a "Super" size and the tampex itself is crumpled but does not appear to be soiled. Also laying on the same chair is a box with "Fram" labeled on the outside. A pair of blue jeans also rested crumpled on the chair. Behind the driver's seat on the floor is an 8-track cartridge tape; an empty coke and Dr. Pepper bottle. Underneath the passenger seat, front, is a little girl's dress, white, yellow, and blue print design, in color. There is also seen a crushed empty "Salem" package, a comb, various polaroid photos, and a pair of little girl's brown shoes. To the rear left of the passenger seat is a blue jack stand and a red comb. There is a CB in the van; the glove box is opened; and I observed it to be littered with uneaten powdered do-nuts which looked stale; its littered with soiled paper napkins.

There are no keys in the ignition. There is a brush on the dash and numerous papers. On the panel door to the rear of the passenger door in the drink holder is observed an opened bean dip, still having some content in it. In the second holder is an unopen Schlitz Beer; in the third holder is a man's black nylon sock.

The van was parked in a brushy area with tall weeds and is about two feet from a fence. There is a gravel road leading off the street. The van is about 43 9/10 feet from the edge of the gravel roadway. I also saw that the van did not have a gas cap. Instead a pair of blue and white jogging shorts are stuffed into the gas tank.

At the scene were Lt. Graham, Capt. Wimbish; Lt. Malcom Pace, Officer R. M. Boos; Sgt. R. Caceras; Sgt. Randy Walker; I.D. Officer Sara Cooks who processed and photographed the scene; Medical Examiner Dr. Rupp and Medical Examiner Assistant G. Risor. Crest Ambulance transported the body to the Morgue.

On this date at approximately 8:50 a.m. I returned to the CID office from Mexico and Mussett. When I arrived I was informed that a patrol unit had transferred a latin female to the station who was later identified as Virginia (Pena) Guerrero. I interviewed Mrs. Guerrero who is the step-mother of Dalia Saucedo. After speaking to Mrs. Guerrero about her step-daughter and the type of vehicle she owned. I determined that a possibility existed that the unidentified female found dead in the van [REDACTED] could possibly be Dalia Saucedo. I then asked Mrs. Guerrero to accompany me to the County Morgue; this was at 9:15 a.m. I contacted the Medical Examiners office and asked to view the body. At 9:50 a.m. Mrs. Guerrero viewed the body. Mrs. Guerrero made positive identification that the dead woman was Dalia Saucedo. I then brought Mrs. Guerrero back to the CID office where I continued my interview. I took a detailed statement from Mrs. Guerrero who advised me of the following. Mrs. Guerrero has been living with the victim and her husband Apolinar Saucedo for the past two months. She further told me that Apolinar works in Houston as an air condition repairman. He works for the victim's brother, Fernando Pena. Apolinar commutes hom on week-ends adn the last time he had been in Corpus Christi was two weeks ago. He was scheduled to come home on Wednesday 11-21-79 for the Thanksgiving Holidays. Mrs. Guerrero told me that Dalia did go out on her husband while he was gone and that this is one of their marital problems. She knows Dalia to be dating a subject by the name of Fernando, also known as "Freddy". Mrs. Guerrero later took this officer and Sgt. Paul Rivera and pointed out his residence to us. I was told that Dalia frequents the Casino and Carousel. Mrs. Guerrero also told me that Dalia and Freddy have been having problems since Freddy is jealous of Dalia dating anyone else. As a matter of fact she said on Saturday 11-17-79 Freddy threatened to "kick her ass" if she were to reunite with her husband.

Mrs. Guerrero stated also that Dalia went to the Casino on Saturday 11-17-79 but returned late that night. Also on Sunday 11-18-79 Dalia again went to the Casino. However on this occassion she failed to return home. Mrs. Guerrero says she next saw Dalia, Monday, 11-19-79 at 8:00 a.m. when she came by the house. She was accompanied by three male subjects who she did not recognize. Dalia told her step-mother she was going to Kingsville to take Johnny Longoria to pick up his wife Georgia Rand. She asked Mrs. Guerrero if she wanted to go. Mrs. Guerrero responded she would not be able to go since she had a doctor's appointment. Dalia then gave her step-sister Rosa a ride to Robert Wilson School and then drover her step-mother to the corner of Lawton and Greenwood where she dropped her off. Mrs. Guerrero states this was the last time she saw Dalia. She had no further communication with her the remainder of the day.

On this date, approximately 7:00 p.m. I interviewed Mrs. Maria Fuentes, of 704 Dolores, telephone #882-6776. Mrs. Fuentes is Jesse Garza's step-mother. She related to me that on Monday 11-19-79 at about 7:00 a.m. her step-son Jesse drove up to the house in a brand new van which was varying shades of brown. She says Jesse came into the house and was bragging to them about his new van. He wanted them to go out and see it. Mrs. Fuentes says she looked out through the window and saw a young woman sitting on the passenger side. She could not describe her, however said she was slender and had black curly hair. She teased him about the van and Jesse finally told her, "its my broads's". She says he stayed a few minutes then left. Mrs. Fuentes states she next saw Jesse sometime between 3:00 and 4:00 p.m. when Jesse returned again. He was driving the van once more. Her husband asked him if he had worked today and Jesse replied he'd only worked three hours. She says Jesse didn't look like he'd been working; rather his clothers were wrinkled like he'd just woken up. Mrs. Fuentes says that he only stayed for a few more minutes then he left. He told her he was going home; that the woman in the van would drop him off.

Mrs. Fuentes says at a later time she had a conversation with her other son, Martin and that the woman was supposed to come back and pick Jesse up at 10:00 p.m. According to what Martin told her, the woman never showed up. Also on Monday 11-19-79 she found out that Jesse never did go to work that day.

On this date I contacted Apolinar Saucedo, of 1806 Cliff Maus, latin male, 26 years of age, date of birth 06-03-53. Texas driver license [REDACTED]. Apolinar advised me he is employed in Houston by his brother-in-law Fernando Pena who is a sub-contractor of Mischer Airco in Houston, telephone #869-6725. He further told me he recieved word of his wife's death through his brother-in-law. He then left Houston to return to Corpus Christi. He did state that while enrout south he was issued a warning ticket by the Highway Patrol. He drives a 1975 Chevy Monza. Apolinar also spoke of having marital problems with Dalia because she dated other men. He further told me that they'd been separated for about three months and at that time she had left for Houston and was living with a guy named Freddy. Apolinar also said he went to Houston looking for Dalin in an attempt to reconcile their marriage. He says at the time Dalia told him it was over and did not want to go back to him. He also told me that about two weeks later after he first contacted Dalia he again located her van at a a Holiday Inn. He made contact with the Inn Keeper and was advised the van had been parked there about ten days, as though abandoned. After showing the Inn Keeper, proof of ownership papers, he then had a key made for the van and then he drove the van down to his sister's house in Brownsville, Texas. He does not know her address but her name is Victoriana S. Sylva. About two nights later Dalia came to Brownsville and took the van back without telling him. Apolinar says that about 2½ months ago they got back together again. He says Dalia still continued to date other men. Apolinar did agree to take a polygraph examination at DPS. I then took him to DPS where he submitted to the polygraph exam given him by Eddie DeSha. After the completion of the examination, Mr DeSha advised that Saucedo had successfully passed the examination.

On this date, reporting officer went to Kingsville with Sgt. U. B. Alvarado and Sgt. Sidney Smith. Once there we made contact with Johnny Longoria and also with Georgia Rand, his common-law wife. I interviewed Georgia Rand briefly and then asked her if she would travel to Corpus Christi with me and give a statement regarding the events of the past few days. Mrs. Rand agreed to come voluntarily.

Once at our office, I continued my interview with her. Mrs. Rand related to me that she and Johnny Longoria have been living together for about a year and three months. Recently, however, she found out that Johnny has been dating a friend of hers who she identified as Rose Gonzales. She says this angered her and so she had been contemplating leaving Johnny. She says that on Sunday, November 18, 1979, she awoken at around 8:00a.m., and at that time went to Jim Simmon's house. He also lives on Tanchahua Street near the Maverick Market. She says she wanted to borrow Jim's car, but Jim was not at home. From his home she went to South Bluff Park where she was going to try and score some pot. Since there was no one at the park, she then went to a girl's house which is located at the back of the park. She knows her only as Yvonne. Georgia states she went to try and collect \$4.00 that Yvonne owed her. Yvonne didn't have any money so couldn't repay Georgia. She visited a while longer then returned home. When she arrived at the apartment, Johnny and Tony Lerma were watching a football game on television. She states she then went and gathered a few of her personal belongings, put them in a bag and got ready to go to Kingsville. Johnny walked her to the bus station. She left on the 2:45 p.m. bus to Kingsville. Georgia further told me that as the bus was driving off she looked out the window. She saw Dalia Saucedo in her van parked near the corner of Power and Chaparral. She further saw Johnny walking up to the van. Georgia stated this was the last time she saw Dalia.

Georgia goes on to say that on Monday evening, she called Jim and asked him to come to Kingsville and pick her up. Jim brought her back to Corpus and since he was going out of town she then spent the night at his house. Georgia says that she watched t.v. late that night and was unable to fall asleep. So around 4:00 a.m., she drove to Ray Benavides apartment and woke up Johnny. She was driving Jim's car and from here they drove out to the island. Georgia says she wanted to talk things out with Johnny. Later that same morning, they returned to Corpus where they stopped at a Whataburger to eat breakfast. Afterwards, she drove Johnny to Ray's apartment where they stayed for a while then she and Janie (Ray's common-law wife) drove Johnny and his belongings to Richard Lerma's house where she dropped him off. She then took Janie back home. She then returned to Jim's house to return the car to him. She states she then ate and later took a nap at Jim's house. Later that night, she went out to look for Johnny as she found out the police were looking for him. She did locate him at Richard's house. She left but returned later to pick him up and they both went to her parent's home in Kingsville, Texas. Their address is 513 W. Richard, phone number 592-1722, father's name, Robert C. Rand.

On this date, reporting officer interviewed Irma Ramirez of 440 W. Ave. G., Robstown, Texas, telephone #387-2673. I specifically wanted to ascertain from Mrs. Ramirez if she was aware of any other individuals who were possibly dating her cousin, Dalia Saucedo. Mrs. Ramirez then informed me that during a conversation with Dalia's stepmother, Virginia Guerrero, she had found out that Dalia had seen an old boyfriend of her's who she identified as Richard Ramon of Petronila. He and Dalia began dating when she was 14 years old and living on the farm with her natural father. On Sunday, 11-18-79, Dalia saw Richard at the Casino and later gave him a ride to Petronila. Afterwards, she returned home at 1806 Cliff Maus. Mrs. Ramirez states that to the best of her knowledge Dalia and Richard never had any disagreements. She says they had remained good friends throughout the past years.

Also while Mrs. Ramirez was in our office I showed her two separate photo lineups. The photos included were #94427, 93733, 95118, 78509, 94601, 151252, 86998, 150437, 53746, 76866, 79862, and #59201. After viewing the photo line-up, she advised me that she had seen the subject in photo #78509 before. She states further that she had seen him speaking to Dalia numerous times at the Casino. She also told me that Dalia had known this subject for at least two years that she personally knew of, as she had observed them conversing with each other at the Casino. Mrs. Ramirez says though that Dalia never did introduced him to her. I informed Mrs. Ramirez then that the man she had identified as knowing Dalia was Pete Olivarez.

ON 11-20-79 a Tuesday Lt. Malcomb Pace assigned reporting officer P. Rivera#306 to assist officer Olivia Escobedo in the investigation involving the above Homicide. Reporting officer along with officer Escobedo met with step mother of the above victim whose name is Mrs. Virginia Guerrero and after meeting with Mrs. Guerrero she took us to an address at 746 Texas where a subject by the name of Fernando Mungia Schilling resides. According to Mrs. Guerrero this subject Fernando Schilling is an ex-boyfriend of the above victim and also according to Mrs. Guerrero this subject had been making threats to the above victim. Reporting officers after being shown the address by Ms. Guerrero went to 746 Texas apt #3 and made contact with Fernando Mungia Schilling. Upon making contact with subject Fernando Mungia Schilling reporting officers asked him if he would voluntarily accompany officers to the station to be questioned reference the above Homicide. Subject Fernando Schilling agreed to come to the station with officers voluntarily. He was also immediately told by this officer that he was a suspect in the homicide and read him his Constitutional Rights. He was brought to the station and brought to an interview room in the CID office and before being interviewed was again warned of his Constitutional Rights from a Miranda Warning Card which he initialed and signed and dated it 11-20-79. During the interview subject Schilling stated that he had gone to work the night before which was 11-19-79 at 11:00 p.m. at the Maverick Market located on Alameda and Doddridge. He stated that he had gotten off of work at approximately 8:00 a.m. 11-20-79. He also stated that he had not seen the above victim in several days and that the last time he had talked to her was on the phone which was approximately 3 days prior to her death. During the interview he was asked if he would submit to a polygraph examination voluntarily and he agreed to take the examination. Reporting officer along with officer Joel Castaneda took subject Fernando Mungia Schilling to the Department of Public Safety and met with the polygraph examiner Mr. Eddie De Shea. Subject Fernando Schillings submitted to a voluntary polygraph examination and according to Mr. Eddie De Shea the results showed that he had no involvement or knowledge as to who had committed the above Homicide. Fernando Mungia Schilling is a white male, age 23, date of birth 6-3-56, his address is 746 Texas Dr. apt. #3, he is 5'11", 160, Texas Drivers license # [REDACTED], phone at home is 854-4723, phone at work is 852-3051. After the examination was conducted he was brought to the station and re-interviewed by this officer. Mr. Schilling stated that on the same date 11-20-79 at approximately 3 a.m. two female subjects by the name of Rosie Gonzales and Abbie Cisneros had gone by the store where he is employed which is the Maverick Market on Alameda near Doddridge and while at the store these two female subjects asked him Fernando Schilling if he had seen Dalia Saucedo at which time he stated that he had not seen her in quite some time. Fernando Schilling stated that one of the two female subjects told him that she had seen the above victim with some subjects by the name of Johnny Longoria, Tony Lerma and three other latin male subjects first names only, Peter also called Pete, Jesse and the third subject named Roger. Also Fernando Schilling stated to officer that these two female subjects Rosie Gonzalez and Abbie Cisneros were employed at the Blood Plasma Center on Chaparral St. And that if I would talk to them maybe they could furnish this officer some information as to who were the subjects seen with the above victim on 11-19-79 at approximatley 3 p.m. After being interviewed subject Fernando Schilling was permitted to go home with out any charges pending at this time. Reporting officer then called the Blood Plasma Center on Chaparral and was advised by the personnel there that these two female subjects no longer were employed at this location and was advised they were currently employed at the Blood Plasma Center on Ayers St. and furnished this officer with a phone number 883-2640 to the Blood Plasma Center on Ayers. Reporting officer called the blood center on Ayers and made contact with Rose Gonzales who is 19 years old and Abbie Cisneros who is 21 years old.
