NARRATIVE
=====

ON 1/11/96, AT ABOUT 2030, MY PARTNER T. SHOBAR NUMBER 275 AND MYSELF O. FULTON NUMBER 481 WERE DISPATCHED TO 1817 SHELBY, REFERENCE A DISTURBANCE WITH A DRUNK WITH A KNIFE.

UPON OUR ARRIVAL WE FOUND THE VICTIM LITTLE JOHN, HIS WIFE WINFIELD AND A FRIEND MAXWELL. THEY SAID MAXWELL'S LIVE IN BOYFRIEND, THE SUSPECT HERNANDEZ WAS DRUNK.

WINFIELD AND HER CHILDREN ARE ALSO STAYING AT MAXWELL'S DUE TO THEIR RECENT EVACUATION FROM THEIR RESIDENCE. TODAY HERNANDEZ TOLD WINFIELD TO LEAVE HIS HOUSE AND TO TAKE HER CHILDREN WITH HER. WINFIELD CALLED HER HUSBAND LITTLE JOHN WHO IS STAYING AT THE OWNES ADDRESS UNTIL THEY CAN FIND A NEW HOME.

WHEN LITTLE JOHN CAME OVER HERNANDEZ WAS ON THE PORCH HOLDING A RAZOR KNIFE. WINFIELD AND MAXWELL WARNED LITTLE JOHN. LITTLE JOHN PICKED UP A CEMENT LAWN ORNAMENT TO PROTECT HIMSELF. HERNANDEZ RETREATED BACK INTO THE HOUSE WHERE WE CONTACTED HIM IN A LIVING ROOM CHAIR. A RAZOR KNIFE WAS ON THE FLOOR AT THE FEET. WHEN WE ASKED HIM IF HE HAD ANYMORE WEAPONS HE SAID YES, AND POINTED TO HIS BACK. WE PULLED A 9'-10' FILLET KNIFE FROM HIS BACK PANTS WAIST BAND.

HERNEDEZ WAS OBVIOUSLY INTOXICATED. MAXWELL SAID HE HAD THREATENED TO CUT HER IN THE PAST. WINFIELD SAID YESTERDAY 1-10-96, HERNANDEZ "ACCIDENTALLY" CUT HER ADULT SON. WE FELT HERNANDEZ WAS A DANGER. HE WAS ARRESTED AND BOOKED.

WE TOOK THE KNIVES AS EVIDENCE. THEY WERE TAGGED AS EVIDENCE BY SHOBAR AN TAG NUMBER 96P-00221. THERE ARE NO FURTHER DETAILS.
