The following was transcribed from the cassette tape which has on it a copy of the conversation which was recorded between Wanda Lopez and the dispatcher Jesus Escochea. The incident occurred on 02-04-83 at approximately 8:09 P.M.

Escochea: Police Department

W. Lopez: Yes. Can you have an officer come to 2602 SPID. I have a suspect with a knife inside the store.

Escochea: What place is this?

W. Lopez: Uh, Sigmor.

Escochea: OK, what's he doing with the knife?

W. Lopez: I don't know. He was outside bumming a ride off this guy and he just told me right now. He just came inside the store.

Escochea: Has he threatened you any yet?

W. Lopez: Not Yet!  
(Conversation with someone other than the dispatcher). OK! What the money?  
What's that?

Escochea: What does he look like?

W. Lopez: What's that?

**Wopez!** He's a Mexican, standing right here at the counter. Can't talk. Thank you.

Escochea: Ma'am?
