MCI INDEX

While on patrol, I was assigned to investigate an armed robbery at the Shamrock Station, 2602 South Padre Island Drive. While enroute, I heard at least two units transmit that they had arrived at the scene. An officer at the scene broadcast information that the suspect had shot the clerk at the Shamrock and then ran north, on foot, behind the Shamrock station. I arrived at the scene and immediately combed the area north of the station. After approximately 20 minutes of searching the area, information was broadcast that a subject was hiding under a truck on Easter near Nemecc and was last seen running east on Nemecc toward Franklin. All units in the area converged on Nemecc and Franklin. After approximately 5 minutes in the area, I heard someone yelling, "He's over here!", repeatedly. Myself and M. Schauer #684 triangulated the suspect. The suspect was lying on his stomach in some muddy water. Suspect, when I told the suspect to "Freeze! Police!", began reaching into his waistband and was tugging at something, as if he were trying to get something out of his waistband. I laid prone on the street, drew my weapon and crawled under the truck at the rear. I was crawling towards and alongside the suspect's legs and feet. The suspect withdrew something black from his waistband, disregarding my orders to freeze. Suspect threw the black object into the water. I advised suspect not to move, that he was under arrest for aggravated robbery and aggravated assault. I told the subject to roll out from under the truck towards M. Schauer. He complied and was taken into custody.
