At approximately 8:00 a.m. I was informed by Lt. Pace to proceed to Mussatt and Old Mexico and to assist officer Escobedo in the investigation. Upon arrival at the scene met with Officer Escobedo who had already secured and checked out the crime scene. At this time met with Lt. Pace, he stated that there was a subject that we needed to talk to, which lived at 1509 Cantwell at apartment #2. Myself, Lt. Pace, and Sgt. Riley Boos from the uniform division proceeded to this location. On arrival went to apartment #2 at which time we observed some blood on the door screen, indicating that somebody had pushed their fists through the screen. Also some blood droppings on the steps in front of the apartment. We talked to Ben Camero, phone #888-5864 who is the resident and owner of the apartments and lives in the front house at 1509 Cantwell. Mr. Camero stated that the subject who lives in apartment #2 was a Jerry Condon and he worked at the Corpus Christi Egg Co. at the end of Mussatt. At this time I was notified by the dispatcher that Patrol Unit had picked up this subject at Memorial Hospital and had brought him to the Police Station for questioning. I proceeded to the police station at which time I met Jerry Edward Condon, date of birth 12-06-57, address 1509 1/2 Cantwell, apartment #2. On talking to Mr. Condon found out that Mr. Condon had been involved in a fight earlier on the 19th at approximately 11:30 p.m. and that he had been drinking quite heavily. That he had left the apartment on Staples St. and had went home leaving a trail of blood from around Agnes and Staples St. to Mussatt St. This trail of blood was picked up and followed to the intersection of Agnes and Staples. Also Mr. Condon was taken to Texas Department of Public Safety where the operator, Eddie De Shea of PS administered a polygraph examination to Mr. Condon. Who voluntarily did this. It was then determined that Mr. Condon had no knowledge of the Homicide of Dalia Saucedo. A black subject by the name of Freddie William Hardy came into the police station to check and see if Mr. Condon was going to file charges on him due to him being in a fight with Mr. Condon on the 19th. This also verifies the severe cut on Mr. Condon's head. Also talked to Mr. Condon's roommate Calvin Rachal, age 20. Mr. Rachal stated in the early morning hours of the 20th that Jerry Condon had come back to the apartment, highly intoxicated with his hand bleeding very badly. Stated to him that he had been in a fight with a black man. This verifies Mr. Condon's story. And Mr. Rachal was very cooperative in giving information. Mr. Condon was then taken back to Memorial Medical Center where he received treatment of his injured hand and told that he may be contacted later. Mr. Condon stated that he would be glad to help in any way possible.

On 11-21-79 myself, Sgt. U. B. Alvarado, and Officer Olivia Escobedo went to Kingsville area where we made contact with Johnny Longoria and Georgia Rand his common-law wife. At this time myself and Sgt. U. B. Alvarado brought Johnny Longoria back to the police apartment in Corpus Christi from Kingsville and Officer Escobedo brought back Georgia and. Upon arriving back at our office at the Corpus Christi Police Station I interviewed Johnny Longoria. At which time Johnny Longoria gave me a sworn statement concerning his activities starting on November 19, 1979 at around 7:00 a.m. in the morning and ending at around 11:30 p.m. Also in the interview two separate photograph line ups were presented to Mr. Longoria at which time Mr. Longoria picked out of the first line 78509 which is that of a Pete Olivarez. In the second line up he picked out picture 150437 which is that of Jesse Garza. For further information on the contents of this statement see voluntary statement not under arrest. Mr. Longoria then was advised that he would be willing to take a polygraph examination, that he did not have, but it would help in the investigation. Mr. Longoria stated that he would be more than happy to consent to a polygraph examination and if we would set up an appointment, he would be glad to be available for this polygraph examination.
