No date on the printouts. Found in DA documents released to JSL in Feb. 2005:

Notes: Of all 6, our CH is **(1)** the closest match in height and weight to the suspect as described; **(2)** the only one with a history of violent felonies; **(3)** the only one with armed robbery; **(4)** the only one who did prison time; and **(5)** is tied with #6 for the longest rap sheet --- and probably has the longest, because our CH's rap sheet is cut off in the middle of 1980.

Baker described the perp as 24 y.o. which is younger than our CH ...
