JSL: And what kind of work do you do?

FS: Ah?

JSL: What kind of work do you do?

JSL: You said that you were married. What was your wife's name?

FS: That's my wife and kids and two sons.

JSL: And who's that gentleman there?

FS: That's me, many years ago.

JSL: And you also have, there's a young woman by the name of Pricilla-

JSL: And who else went to the Casino club that you know?

FS: A bunch of people that I knew, Carlos Hernandez, Joe Oevo [?], I had friends.

JSL: And how about Dahlia Saucedo, did she go to the Casino Club?

FS: Yeah, she went to the Casino Club. She used to go to the Carousel. In fact, that's how I met her, at the very beginning. She was coming out of the Carousel, walking down the street, crying. I pulled over, tried to be nice and offered her a ride. That's how things got started between me and Dahlia Saucedo.

JSL: And where did things go from there?

FS: Well, it kind of got out of hand. Because at first, when I first met Dahlia, she played this little innocent role. She was having troubles with her husband and had a boyfriend. So, just one thing led to another, and before you know it me and her started doing things. So we did that for about a month or two, and I finally knew that I wasn't spending enough time with my family, and I told her, "Hey, Dahlia, this has to end, because my wife's taking notice, and I'm spending more time over here than

I'm spending at the house." So one day she said, "If that's the way you feel about it," and I said, "Yeah, that's the way I feel about it. I'm sorry. I'm not saying it's going to end, but I'm letting you know I've got to slack off. I've got to spend more time with my family."

FS: So one day I was at work. I used to work for Save a Dollar, no Save More, I can't recall. But anyway, it was a little convenience store located on Weber and Galahar. She came by one day. She called me first before she did because she said she was fixing to go to Houston. When she came, she came with a brand new van and she said she needed to talk to me. That particular day she kept asking me to take the rest of the day off. I said, "I can't do that." She said, "Come on. You've filled in for other people, get somebody else to fill in for you." I said, "You know what, let me see what I can do." And I called one of the workers and asked him if he could come in fill in for me because I had filled in for him several times. In fact, Jamie Luby had a niece that was working there. I can't recall what her name was, it was many, many years ago. But she was working that day. So I took off, I guess it was two o'clock or three o'clock in the afternoon. When I got in the van, that's when she started talking to me about her real life, not the lies she was telling me before. It seemed

that something had happened at the house, her house, and one of the kids got killed and she came into a lot of money. She had a lot of money. Supposedly she had bought this van for me. This van was supposed to be for me, and all this. At first I couldn't believe it. "Why are you telling me all this now," I said. "Why did you make me spend all my money all that time that we were together, for the first two months, and I go home broke when you've got all this money." She said, "I just wanted to see if you really had feelings for me. I didn't want you to have feelings for my money. I wanted to see if you're for real, and I can see that you are."

FS: We're going down the road. In fact, we're right here on Staples. I see this little '72 Mustang Mark One. At that age I was fascinated by fast cars and good-looking cars and stuff like that. I saw this Mustang, I really fell in love with it. She said, "You like that." I said, "Yeah." She said, "Well, pull over, let's look at it." We pulled over, we looked at it. I talked to the guy. It was Classic Motors, right here on Staples and Craig Street. She said, "You like it?" I said, "Yeah." "Well, try it out." The guy comes out, he says, "The clutch is slipping," and all this, but I tried it out anyway. By the time I came back, they're already talking about getting the clutch fixed.

She says, "Do you like it?" and I say, "Yeah." She says, "Do you want it?" and I say, "Who wouldn't? It's a nice car."

Apparently, they made a deal, the guy and Dahlia. The following day she came in with a cashier's check, bought the car for me. So that really stunned me, you know what I'm saying. She kind of really bought my love. That's what she did. It wasn't that I fell in love with her or loved her or anything like that, because I had my wife and kids. At that time I was, wow, crazy. One thing led to another and me and Dahlia ran off together. I shouldn't have done that, but I did.

FS: So we ended up in Houston. I took my kids for a little while, back and forth. I stayed gone for a while, from my wife, but I supported my wife while I was on the lam. My kids were well taken-care-of. She was taken-care-of. Dahlia was sending money every week through the Western Union. She was real nice about it. She accepted that my feelings were towards my wife, not towards her. Dahlia was just, I guess she was fascinated by me. I don't know what it was that really attracted her to me. Anyhow, I just kept living that life, that life of spending and having and enjoying it. I guess it comes once in a lifetime, that's the way I looked at it at the time. And I thought I would enjoy it as best I could. But then, when the time came that my mind was

really saying "Hey, this ain't right. Go home." I met this other girl up in Houston, and she's actually the one who convinced me to come home to my family. But that's what I needed. And that's what I did. So when I came home, my wife accepted me, and we tried to get everything back together the way it was.

FS: But Dahlia kept getting in the picture. She kept coming around the house, trying to make me jealous by driving by with other guys. Stuff like that. One day we had it out because I came home and she was playing with my kids and my wife, trying to win my wife to her side. I got pissed off. I said, "Dahlia, you need to quit. You need to quit, really. You need to quit coming around, messing with my family, I don't need this." Things got heated up between us at that point. She started cussing and running back and forth and everything

I used to smoke a little weed back then, drink, especially drink. I would run into her. I'd see her going up and down. She would be following me and I'd see her. In fact, I'd see her with Carlos in the van several times. I'd seen her with my best friend. I'd

FS: At that time I was working at the Maverick on Alameda, right before you get to Weber. One day I was coming home . . . In fact, that day, I was with this friend of mine. He came over to the store, and that morning I met him. We were drinking. We drank till about 10:30 in the morning. I got off at seven in the morning, so we drank about 10:30 in the morning. I was tired, and I said, "You know what? I'm going to go, Jesse." It was Jesse Cano.

FS: I went home, and when I got home I had a beer in one hand and a little roach in the other. I was smoking. I was fixing to go to bed. Like I said, I smoked a little weed, I'm not going to lie. Anyway, I was smoking the joint. I was coming in through the door. Next thing you know, here comes the cops, all running down, back and front. They asked me who I was, and I told them who I was, put the joint out, put the beer down. They said, "Well, we need to talk to you." That's when I found out what happened to Dahlia, that she had been killed. It really

stunned me, because I couldn't believe it. But when I got to the police station I saw her little baby girl standing up on top of the desk. And I'd seen some of her family, I can't recall really, who it was, but I knew some of the family. And I'd seen the baby girl crying, and that's when I realized that really happened.

FS: After that, they investigated me. They took me out to the Texas Public Safety department and they asked all kinds of questions and stuff like that. It's just like I told them, I was at work. I worked from eleven to seven in the morning. Next thing you know they had this other guy named Jesse [Garza], they had my best friend, Johnny Longoria, they had four or five different people, because they said that they had found four or five different sperm cells in Dahlia at that particular night that she was killed.

FS: They mainly found a lot of evidence towards Carlos Hernandez. But they were more focused on this other guy named Jesse [Garza] than they were on Carlos. Because they found fingerprints, they found pubic hairs, they found sperm, they found beer cans that had fingerprints that belonged to Carlos, stuff like that. They way they killed her, wasn't very nice. Apparently they raped her and choked her. They said -- I've never seen any pictures of it or

anything like that -- but they said they carved an "X" on her back. They never showed me a picture of Dahlia, actually, when she was dead. If they did, maybe I didn't want to look at them or something. I can't recall them showing me anything. But they said they carved an "X" in her back. But they found a knife and they found everything in the van. My understanding, I don't know.

FS: I had Paul Rivera, who was a homicide detective at that time, we kind of talked on a regular basis. He always expressed to me that Carlos had a whole lot more to do than they can see. But, like I said, they were more focused on Jesse. In fact, I think they indicted Jesse, then they acquitted him. I remember them calling me to court one day, and I presented myself over there.

FS: I guess I was, maybe, five, ten minutes on the stand, I can't recall. It wasn't really much, they just asked me about Carlos Hernandez and stuff like that. And I told them that Carlos was a violent person, which he was. Carlos was very violent. He threatened my life many, many times. Many times. I've always dealt with him fist to fist and I've always took him down. I've always had the opportunity of taking over whatever he had going towards me. He would pull clubs, or he would pull a knife, he's even picked up trash cans and tried to hit me with them. He

always threatened me. He says, "I'll kill you, just like I killed that bitch of yours." He would say that. But he would only say that on a drunken rage. When he was normal, he was a completely different person, but when he drank, don't get around him, because he'll stab you in the back. That's the type of person he was. Very untrustworthy. You don't know one move from the other. That's basically it.

JSL: When Carlos made those statements to you, would you describe to us what exactly would Carlos say to you . . . Let me just ask you straight forward: Who killed Dahlia Saucedo as far as you are concerned?

FS: Me, as far as I'm concerned, Carlos Hernandez did it. Carlos did it. I'm going to . . . That's my gut feeling. Because he came to me. I would come home from work, and he would be at the house. My wife knew how I felt about having him around the house, especially when he was drunk. Ok? We were constantly arguing, me and my wife, because of her brother being around the house. I told her, "I don't want the dude around here. I don't want him. What do I have to tell you to make it clear with you?" Like I said, that was several times. In fact, one particular fight that I got into with him, my friend, Johnny Longoria -- he used to live

right here on 12th, he passed away a while back, he got shot in Houston. Anyway, we were at the park and we were drinking. South Bluff Park. [Note: South Bluff Park is the park where Michael Ortiz heard Carlos Hernandez confess to three murders, Saucedo, Lopez and the woman under the bridge.] We went to the store -- I believe it was 7-11, I can't recall -- to pick up a couple six-packs of beer. And we were on our way back.

FS: At the time, before I left, I had a little stereo, radio that we had on top of the one of the barbecue tables and we were listening to it. Well, my brother in law, Carlos Hernan -- I mean Javier, not Carlos, Carlos's brother, Javier -- took the radio home. That pissed me off, "What the fuck?" So I went over there, me and Johnny went over there to get the radio. It was just about a block and a half away. So when I went up there I started hollering, "Hey, where's my radio, man? How come you took it?" "Man, you want your fucking radio?" and he got the radio and he threw it. It landed all over the sidewalk, batteries flying everywhere and everything, and that pissed me off. And I took him around the corner, whipping his ass for doing that. Well, Carlos Hernandez comes out with this ax handle. And he's coming at me with the ax handle, and that's when Johnny Longoria comes out and says, "Hey, what the fuck? You want to fight him, fight him hand

to hand." "Oh, You want some to?" so he goes at Johnny and starts whipping Johnny with the ax handle. Next thing you know, I ran up to him and I said, "Hey, Carlos, come on, man, leave him alone." He's whipping him with this ax handle, basically wanting to kill him. So when I went up there to him, he starts coming towards me with the ax handle. Somehow I managed to get the ax handle off him and I threw it up on a roof of a house. So that's when we went hand on hand. And I started whipping the shit out of Carlos.

FS: But before he did that, before we got into that fist fight, he's coming with the ax handle before I took the handle, and he says, "I'm going to kick your ass. I'm going to kill you just like I killed that bitch of yours." Just like that. Every time we got into a fight, he would always bring that up.

FS: Dahlia Saucedo. "Just like I killed that bitch," he was like that. He would always say that on a drunk rage, though, you know what I'm saying? He wouldn't say it . . . Like, the following day he would come in apologizing to me, saying, "I'm sorry about what happened yesterday." This was several times he did this to me, several times.

FS: My wife told me . . . she started crying one day and she says, "I'm going to tell you the truth. I really shouldn't be telling you, but Carlos confessed to me. He told me that he killed Dahlia. He says it's because he didn't want to see me suffer any more." He was tired of me fucking around, always seeing me fucking around. Which I did, I was a player. I used to have little girlfriends on the side.

FS: Back then, it was normal. I was young, I was crazy, I had a lot of women. My wife knew I was like that. She accepted it. As I grew older, common sense told me it wasn't right. I quit, I quit doing stuff like that. But when I was young I was wild. And he would always see this. He was kind of jealous of me. I would

FS: Common sense told me that she was. Personally, I never knew that she did. I knew that something was going on.

So when the trash was coming by to pick up trash, for some reason, the trash truck backed up into her driveway. And the baby happened to be playing in the driveway and they ran over her. But that's what she told me. After that, I never talked to her about it. I know people have feelings. I just never mentioned it again, never questioned her about it, how, why, where were you.

JSL: Do you remember an occasion when you had a fight with Carlos Hernandez when an ambulance was called?

14:20:10

FS: I can't recall, to be honest with you. I know I've had several fights with him, a bunch of fights. One time we had a fight right here on 10th Street. He had a butcher knife and he was chasing me around with the butcher knife. I believe I picked up the trash can and I started going towards him. Somehow I ended up with the knife in my hand, chasing him. Next thing you know, the cops drive up. They see me with the knife in the hand, thinking I'm the one that's . . . I tried to explain to them, "Whoa, whoa, whoa. Wait a minute, he's the one with the knife. I just . . ." Times like that, when cops came around . . .

FS: We had a fight out there on Laredo Street one day. I remember Javier and Carlos, they came at me. I got it on with Javier first, then Carlos came at me, and then his mother came at me. I can't remember whether I hit Fidela or what. All I know is, it really escalated it to a major fight. I saw cops coming around and I started jumping on top of cars and jumping fences and running. That's all I recall. The following day he came over like it was nothing, with beer in hand and everything, "Hey, here."

JSL: What . . . this is a hard question to ask of you, but I want to ask it. What was the relationship between Carlos Hernandez and Pricilla, your stepdaughter?

FS: I'll be honest with you, I was really scared of this dude. I mean, I fought him off for a long time. And I just wanted to

I didn't know how to deal with it at the time. I really felt like I wanted to kill that son of a bitch because of what he did. I knew eventually we were going to get to a point where we were going to hurt each other. One of us was going to hurt somebody real bad. But I wasn't looking forward to it. I just wanted to wait for the time, and when the time came, that's when I was going to take out my anger on him because of what he did to my stepdaughter. I don't know where it would have took us, but if I had to, I would have killed him.

FS: He's no good, man. The dude was no good, no good. And it wasn't just my daughter, believe me, because I've seen him. He used to hang around this laundry right there on Park and Staples. It used to be Don's Laundry at that time. There used to be a restaurant, Hermando's, across the street. Next door used to be the 7-11. It used to be kind of the hangout for the neighborhood there. And he would constantly hang out there. And he would

He was throwed [sic] off, he was throwed off, believe me. Like I said, he used to scare the shit of me. Paul Rivera will tell you, he told me the same thing, scared him. That's the detective we're talking about. That's how bad that dude was.

FS: Yeah, I know Eddie Garza. Eddie Garza was my best friend's uncle, Johnny Longoria, the one who got killed up in Houston. We grew up together.
