**Interview of Dina Ybanez
07/13/2004**

Also present, Norma Cavasos and Cathy _____.

“I knew he did it to the lady in the van and I kept being friends with him. Lady in the Shamrock.”

Met his girlfriend first, Cindy. He was hanging around with house. Then he'd drink and he'd say he had a blackout. He was in a car accident; missing part of brain. He put the knife on the other people. From the neighborhood.

Cindy – stupid girl. Go get hookers for him. Working at Greenwood. Br__y moved to Houston. In love with him. Wouldn't...

2-3 years prior. Carlos – we used to go through his paperwork. He went through Dahlia's papers. Then another case – also a girl he stabbed. She died too. He ran. They got someone else. Same as DeLuna.

Little girl. Andy – she married when 16. 1958-1974. 1985 or 1986 when met him. He was always walking around with bicycle in front of her house. Got arrested and left because he was there drunk.

His apartment – go with Cindy and he would make fun of things. Hancock was his apartment. He'd be drunk and go to sleep talking shit.

1st. Stabbed her, carried her in back and tried to rape her. Different look in face. Ugly like that picture. Early on, she said “pain” as if talking about this reflected painful memories on CH's part. Talked about Dahlia most of the time; less about shamrock.

CH on Shamrock incident: CH – ran the other way. CDL – stupid for not running fast and for getting under cars.

Stabbed her. He ran, they got that other guy. Made fun because he had same names he called Carlos. [His *tocallo*.] He went up to her and put the knife on her. D: Why? He looked and got mad.

“Put the knife on their life.”

Sons Johnny and Andy. Didn't like me going there watching TV. They heard what CH said and didn't like it.

Separated from Andy Sr. in 1989. Get drunk with Cindy and Carlos. Vera – black lady. Tina is dead. Cruz is dead. Maybe others around. Lucy on 7th Street. Girlfriend – she moved; everybody moved. Way older, also alcoholic. She was Anglo.

Cindy is in Houston – heard from people at the library. Mom – moved Cindy. Brother a football player.

Hernandez's clothes: He always wore a t-shirt and jeans. Size 8 1/2 shoes – tennis shoes from payless. He was sloppy, ugly. His hair was always like that. He looked homeless. Would wear a flannel shirt when it got cold – squares, plaid. Real big – loose. He looked fat because clothes were loose

Hernandez's drugs: Busch beer – always had a bottle in the pocket. Smoked Marlboros. Did cocaine.

DY signed paper for John Kelley. JK said best thing was to sign papers and get out of town. This was to protect her son who stabbed CH to protect her, and to get CH out of her hair.

CH stabbed me and turned me over and said I'm going to do to you what I did to Dahlia. I knew what he meant. My two oldest boys took a stick and beat him on the head on a soft spot. I fell on the porch. CH took off running and the little boy followed him to Maverick Market. Black out.

[JSL question, not asked. What did Cindy do at that time?] Cindy was baby sitting the kids that night. DY came home and got out of the car and he (CH) pulled me out of the car. Put knife on my neck. Then she was still. He wanted sex.

Casino Club on Port Street & Marga__. It was near a used furniture store and Popeye's. Closed it. He would go there. There were killings, stabbings and fights. Dance club, served alcohol. It's now a second hand shop.

Later CH came back and said, I'm going to make sure you die.

DY to Peso: When you left after last interview. I couldn't sleep for 2 weeks.

What CH said re: Lopez affair: Carlos DeLuna was running under cars – being stupid. Carlos H. ran away; the other way. He was on the corner watching CDL get arrested. Dina and Cindy used to sneak into CH's things and read his papers. (This doesn't sound

right.) He had a lot of papers from lawyer – John Kelley. He had papers from others. 3 or 4 cases. Very unclear but either he had his own court papers or had court papers from other cases or both. [Could she have learned of Dahlia’s case from Diana Gomez’s statement?]

When CH attacked DY: CH went into pocket and came out with knife. Buck knife. She was fighting him and – didn’t feel stabbing. Grabbed his knife. Big, but it folded. Buck knife – she cut her hand and threw it away. He grabbed it again and turned her over. She’s yelling and kids came.

Cindy had moved into Dina’s house one week before, and he was unhappy at her for leaving and me for having her. Andy and Johnny – They’ll talk to Peso. They. “Grew up to be really bad.”

Huntsville – Andy – he wants to kill the whole world.
Woodville – Johnny – 1 hour away.

I was trying to get help. Johnny was closer to Carlos; Johnny went a lot of places with Carlos. I told YB not to say anything to Johnny or Andy Y except that Peso was a good man and they should talk to him.

DY’s drug rap: April 29, 2003: picked up.
May 2003: dropped off in Mexico and her son came and picked her up. 30 minutes.

Back to the 1989 thing. DY signed paper for Mr. Kelley. He promised me that if I signed it, CH would stop coming after me and it would get my son out of trouble for stabbing CH, son is age 13. Signed something saying “passionate love,” “heat of passion.”

CH would say: He was too smart to be caught and convicted.

1974 – Andy & Dina Married
1979 – Dahlia Saucedo
1983 – Shamrock
1983 – Assault
1985 – Assault; pregnant with Mikey; met Carlos.
April 1986 - Mickey
July 1986 – Assault
December 1986 – Assault
1988/1989 – Separated from Andy
April 15, 1989 – stabbed.

Mickey used to like Carlos.

“Jesse” – name who got blamed for Dahlia.

Carlos arrested a lot – alcoholic.

Weren't going to convict him because they had more evidence against Jesse than him. Jesse spent more time in prison then.

He said he did it in front of little girl while he was stabbing her. I thought he was bluffing. I didn't believe him.

CH was drinking, doing drugs. He wanted \$. Wanted to kill the little girl, but saw someone coming.
