And he started running away. Carlos ran.

**PC:** Tell me about what you remember from that day.

**DY:** I don't remember nothing. I just remember that I got off of work, and he was waiting for me up there. And then, I got out of the car, and he just came up to me and put a knife on my neck. And he wanted to rape me, and I didn't want to let him, but when I saw the knife on my neck I wasn't going to fight. So I let him. And then, when he put it back in his pocket I started fighting with him and I was going to let myself, but by the time I knew it I was on the floor, and my little kids were hitting him with sticks on the back. And he ran, Carlos ran. And Cindy didn't want to call the police, because she didn't want to get Carlos in trouble. So I was just there bleeding. When they took me in I was already, like, out. But I remember that they got Carlos at the store. And he said he had a blackout, like always. He was always claiming blackouts. So they didn't do nothing to him

because of that. And then another time he came over to the house, because I didn't move right away. I wasn't working, nobody wanted to help me. My little boy chased him [Carlos Hernandez], he[my son] was thirteen years old, and stabbed him in the back, because he didn't want to leave me alone until I moved to San Antonio. It was like three times that he came bothering me after that, after he stabbed me. He was very violent.

Carlos was always making her do things for him that she wasn't supposed to. And then Carlos started acting different. He was always drunk, dressed real sloppy, doing drugs. And he was always bragging about things that he did, like stabbing people. He talked about two girls that he did. One of them was Dahlia. I don't know her last name or anything, but he was bragging about the way he stabbed her and he was going to, or, he put an X on her back. And that he had, Carlos killed her in front of her little girl. And that he thought about doing the little girl too, but he didn't. And then he, Carlos was always bragging about the other one that he did at the gas station, because somebody else was arrested. He would call him his "tocayo". And he would laugh about it, because he got away with it, and somebody was paying for something he didn't do. And then, after I met him for a while, he stabbed me too. I never thought it would happen to me. You know, I never... [pause] I don't want to start crying. [starts crying]

They were very violent, always thinking that someone was going to hurt them. So, they will defend themselves before anything happened to them. But Carlos got them like that. He was always ... making fun of Carlos DeLuna, and that other one, for Dahlia. Talking about how he stabbed her and then he started running and they caught the other guy. Laughing, because his "tocayo" was going to pay for something like that, even though he didn't do it. Just because they look the same. [big pause]

**PC:** Tell me a bit more about Carlos Hernandez and the way he dressed, the way he behaved in front of other people. Where he would go to if he went to nightclubs.

**DY:** Carlos used to dress real ugly. He looked more like a hobo. He would go to "El Casino." And he would always be walking with his quart bottle because he was an alcoholic. But he was, he was more like a hobo. He never looked normal. When he was drunk he looked uglier. He had an evil look on his

He didn't have no bone right here. It was like, deep. So that's why he was always doing everything he did. And the lawyer would always say he would have a blackout. That's what he claimed with me. But he was violent. He was always threatening people with knives. He would say, I'll put the knife of their life if they mess with me. And that's the first thing he would think about, the knife. He was always looking for trouble. You didn't have to pick on him so he can do that do you. He was always doing it.

**DY:** White t-shirt. Jeans. His beer. And in cold weather he would wear a flannel jacket and tennies. He was real sloppy. He looked more like a hobo.

And they were the ones that saved me when Carlos was stabbing me. They were little at that time, but they saved me. They've been in the penitentiary for eleven years. And I feel like it was Carlos fault because they weren't like that. Then after that they started acting all different, being afraid of everybody, thinking everybody wanted to hurt them, the way he did me. Fighting. They were good kids. I tried to get
